The Florida Association for Play Therapy would like to invite you to be a vendor at our 2026 annual conference. Our attendees look forward to shopping for new products. We hope you decide to make yours available to our 150-200 expected participants.

The conference will be held at DoubleTree by Hilton Hotel Orlando Airport. Along with breakout sessions by Florida play therapists, we will feature as our keynote Maria Laquerre-Diego. Vendor areas will be open from 8am to 5pm both days. Set up shall be 7am Friday and tear down after 4:30pm on Saturday. All tables must be fully set up by 7:45am on Friday. Vendors will have the option to lock up their materials each night in our locked vendor room or cover their booth. Security to monitor the booths is not available.

Table: The venue will provide each vendor with either 6ft to 8ft table(s) at the location discretion as well as two chairs (per table). Vendors are expected to be in attendance both conference days. Vendors will provide their own business identification and display. FAPT will not provide table skirts, computers, square readers, extension cords, or any other materials. FAPT cannot guarantee access to wifi and electrical outlets, please indicate if you are requesting access and we will attempt to fulfill this request. Admittance to the conference workshops is not included in the vendor fee. Lunch is on your own both days and not provided. Vendors may enjoy the continental breakfast and snacks provided by FAPT.

All vendors must have their tables manned throughout the conference. FAPT will not provide volunteers for vendors. If a vendor is requesting to have their items mailed ahead of time, all packages must be fully received by April 4, 2026. If packages arrive after that time, FAPT will not be held responsible for transportation to the venue. Conference chair, Marla Berger, will provide a mailing address to vendors by February 1, 2026.
